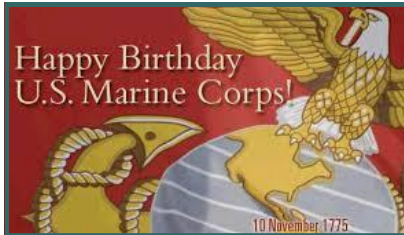

Jasper Brabham Varn, Jr., Brigadier General (Ret.)

Brigadier General (Retired) Jasper Brabham Varn, Jr., age 90, entered into rest on October 16, 2016 at his Generations of Irmo assisted living home.

He was the devoted husband of sixty-five years of Mrs. Barbara Wiles Varn. BG (Ret) Varn was born on May 24th, 1926 in the Colston Community of Bamberg County. He was the youngest child of the late Jasper B. Varn, Sr. and the late Florrie McMillan Varn. He was pre-deceased by his brother, Floyd Monroe Varn (Gigs) and Florence Varn Priess.

Mr. Varn graduated from Bamberg High School in 1941 and attended the University of South Carolina from 1941 to 1945. He served his state and country as a member of the S.C. Army National Guard for 40 years. His last assignment was the position of Deputy Adjutant General. Mr. Varn was employed as a S.C. National Guard Technician for 39 years and retired in 1987. He received numerous prestigious military and civilian awards.

In addition, he was a Past District Deputy Grand Master of the 5th Masonic District of SC. Masons, a Past Master of Union Lodge #247 A.F.M in Ehrhardt, SC., a life member of Ornan Lodge #38 A.F.M. in Bamberg, SC, a 32nd Degree Scottish Rite Mason, a Yorkrite Mason, a Shriner, and a member of the Order of the Eastern Star.

He was a devoted member of the Colston Branch Baptist Church where he was a past Deacon and Sunday school teacher. He was also a member of the Bamberg Lion's Club, the Gideon's International and a **Life Member of the Sons of Confederate Veterans (Rivers Bridge Camp)**.

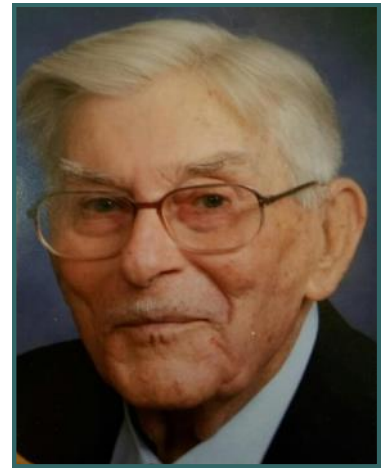
He was an avid outdoorsman and enjoyed hunting, fishing, boating, gardening and farming.

BG (Ret) Varn also previously served as a member and chairman of the Bamberg County Council and as the county's representative to the Lower Savannah Council of Governments.

He was a 60 year member of the U.S.C. Gamecock Club and was a past president of the Bamberg Gamecock Club. In 2014 he was recognized as a U.S.C. "Legendary Fan of the Game."

He is survived by his wife, Barbara, his son, Jasper B. Varn, III (Jappy) and his wife Jill of Irmo, SC. and his daughter, Carla Varn DuPre and husband Paul of Columbia, SC. He is also survived by his grandchildren, Jasper B. Varn, IV (Brab) and wife Jillian of Chapin, SC, Shannon Varn Anderson and husband John of Chapin, SC. Brett C. Hammond of Irmo, SC, Madison S. Hammond of Irmo, SC, J. Paul DuPre, III and fiancé Kortney Baker of Lexington, SC and Wiles M. DuPre, Clara M. DuPre and Patrick L. DuPre all of Columbia, SC.

November 10, 1865; Another Infamous Day

In the years after the war, many books and articles were written about Andersonville and the trial of Wirz. With few exceptions, the truth of Andersonville escaped these accounts. The trial of Major Henry Wirz was and is a national disgrace.

A Pardon Scored

Two nights before he was hanged, three men visited Wirz in his cell at the Capitol Prison. The men told Wirz that they were agents of a powerful member of Congress, and that if he would be willing to testify that Jefferson Davis was responsible for the deaths of the prisoners at Andersonville, Wirz would be pardoned and set free. When Wirz indignantly refused their offer to purchase his liberty with perjury, the same men communicated the offer to both Wirz's defense attorney, Mr. Lewis Schade, and Wirz's attending priest, Reverend F. E. Boyle.

Conclusion On November 10, 1865, the sentence was carried out. The request of Wirz's family for his body was denied, and he was buried in the prison yard beside the Lincoln conspirators. Convinced of his client's innocence, Louis Schade wrote an "open letter to the American public" on April 4, 1867, in which he attempted to explain how Wirz had been unfairly convicted.

In the years after the war, many books and articles were written about Andersonville and the trial of Wirz. In 1908, the United Daughters of the Confederacy erected a monument to Wirz in the town of Andersonville, where a memorial service for Wirz is still held annually. In 1977, the Sons of Confederate Veterans named Wirz the "martyr of the Confederacy" at their national convention, and in 1981 that same organization awarded Wirz their Confederate Medal of Honor.

That Wirz was a scapegoat, tried in order to incriminate the Confederate leaders and to deflect criticism from Secretary of War Stanton, seems obvious. That Wirz was unjustly convicted is also clear to the student of Andersonville and the Wirz trial. As one author aptly wrote, "the nature of the food, the number of the inmates, and the lack of comforts were as totally beyond his control as was the heat of the southern sun."

In the state archives in Richmond, Virginia, there is a letter written by an ex-Andersonville prisoner in 1919 which states, "I have alienated the friendship of many old comrades and friends by telling the truth as I saw it about Major Wirz and his innocence, but I am content and still firm in my belief

that history will correct itself, prejudice illuminated, and the truth recognized." I hope that this article will, in some small way, help the truth to be recognized. The trial Henry Wirz was worse than a mistake, worse even than a miscarriage of justice. The trial of Major Henry Wirz was a national disgrace.
